and the Mountain School at Winhall (the School), are the Parties to this Agreement. The Parents hereby confirm the enrollment of the above-named child(ren) at The Mountain School at Winhall for the 2011/2012 school year. In consideration of the mutual promises contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties promise and agree as follows:

- Parents will send the children named above to the School for the entire 2011/2012 academic year. Parents will pay the full year's tuition to the School. Parents may arrange with the Stratton/Winhall School District Board to make the tuition payments on their behalf; however, Parents are ultimately responsible for the payment of School tuition. If a parent is a resident of a town with a voucher, it is his or her responsibility to obtain payment from that town; but again, Parents are ultimately responsible for the payment of School tuition.
- Enclosed is a deposit of \$1,000.00 per child. If a Parent is a resident of a town with a voucher, it is Parent's responsibility to obtain payment from that town. Residents of Stratton/Winhall may arrange for the Stratton/Winhall School District Board to pay this deposit.
- This contract commits the Parents to the payment of the full year's tuition. Kindergarten-6th Grade tuition is \$12,900 and 7th-8th Grade tuition is \$13,100.
- The balance of the tuition is due in two equal installments on July 1, 2011, and October 1, 2011, except for parents who have obtained written approval from the School for alternative payment plans, including Stratton/Winhall residents who have arranged for payment by the Stratton/Winhall School District Board.
- The School will guarantee a placement at the School for the children named in this contract for the 2011/2012 academic year and make all preparations for their attendance. The School will rely on this contract to make financial decisions to prepare for the attendance of these children. The School will make certain financial decisions based on the number of children who have been contracted to attend for the entire academic year, including, but not limited to: contracting with staff and faculty members, setting class size, purchasing materials, and allocating other resources.

- Parents acknowledge that withdrawal of students after this contract has been signed will not release them from their obligation to pay tuition for the full year. Once this contract has been signed, only the Board of Trustees of The Mountain School at Winhall has authority to release a Parent from his or her obligation to pay the full year's tuition. Specifically, if a student is withdrawn after the contract has been signed, but before July 1st of the academic year, then Parent(s) will still be responsible for the initial payment of \$1,000.00. If a student is withdrawn after the contract has been signed, but on or after July 1st of the academic year, then Parent(s) will still be responsible for payment of the full year's tuition.
- Parent(s) will abide by the school's policies, procedures, handbook, and Parent Responsibility Contract. Parents understand that The Mountain School at Winhall parents are expected to support the school's programs, volunteer time and/or resources, and participate in designated events.

The Mountain School does not discriminate in any way based on race, color, ancestry, place of birth, gender, gender identity, sexual orientation, marital status, ethnic origin, national origin, citizenship, religion, genetic information, or disability or any other category protected by state or federal law in the admission of students, the awarding of scholarships, financial assistance, or in the provision of services and access to MSW educational and extracurricular programs and the School's facilities. By agreement between MSW and Windham Central Supervisory Union, special education services are provided through the WCSU for MSW students eligible for those services.

We, the Parent(s) and the School, have read this contract carefully, and understand its terms. We acknowledge that it is a binding contract, and agree and consent to its terms. We also acknowledge and agree that our execution of the Tuition Authorization Form is our notice and request to our home school district to pay tuition for our child to MSW.
